Dear *Chandrima ji,*

I am writing to seek the support of your Association in the dissemination and effective implementation of the **Textile Statistical Returns System (TSRS)**, a web-based platform introduced by the Office of the Textile Commissioner in August 2026. The portal facilitates online submission of statutory Annual Statistical Returns (ASR) and Monthly Statistical Returns (MSR) by textile units registered under the Factories Act, 1948, including ginning and pressing factories, spinning mills, weaving and knitting units, composite mills, processing houses, man-made fibre and filament yarn units, surgical cotton and padding units, woollen goods manufacturers, ready-made garment units, made-ups manufacturers, technical textile units, and cotton traders. TSRS serves as the national digital infrastructure for collection of statistical data relating to the textile sector.

2. **Submission of statistical returns is mandatory under the Collection of Statistics Act, 2008. Non-compliance attracts penalties under Sections 15(1) and 15(2) of the Act, including a penalty of up to ₹1,00,000 in the case of a company, with an additional penalty of up to ₹5,000 per day for continuing default.** Accurate statistical data is essential for monitoring production, employment, capacity utilization, trade and other key indicators of the textile sector. Despite sustained efforts by the Office of the Textile Commissioner through its Regional Offices and Integrated Textile and Apparel Development Centres (ITADCs), registration and filing of returns on the TSRS portal remain below the desired level.

3. To facilitate compliance, the portal provides a detailed User Manual and a short instructional video for registration and filing of returns. A dedicated helpdesk e-mail has also been created for resolving technical issues. Regular system-generated alerts and reminders are being issued to registered entities to ensure timely submission of returns.

4. In view of the above, I request your personal intervention in sensitizing all member units of your Association regarding their statutory obligation under the Collection of Statistics Act, 2008. Your Association may kindly encourage and facilitate all eligible member units to register on the TSRS portal and submit their ASR and MSR within the prescribed timelines. The Regional Offices of the Textile Commissioner shall extend all necessary support in this regard.

5. Any policy, technical, operational or awareness-related bottlenecks encountered by member units in respect of the TSRS portal may kindly be brought to the notice of this Office for prompt resolution. Such issues may be communicated through the dedicated e-mail ID: statistics.txc@gov.in.

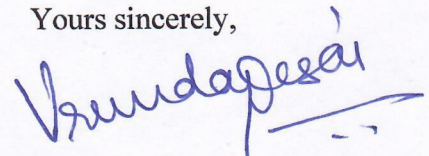

The data submitted through TSRS will be used solely for statistical and policy-making purposes for the growth and development of the textile and clothing sector. The confidentiality of unit-level data will be strictly maintained in accordance with the provisions of the Digital Personal Data Protection (DPDP) Act, 2023.
